- 6) New Business:
 - Dave Muelners Mr. Muelners appeared before the board to request a reduction in the road frontage requirement a on lot of Tower Ave. Make made motion to allow reduction, seconded by Ron. MSC (3-0-0) There was also discussion regarding the width for the township plow to be able to turn around. Mr. Muelners will address that with the new driveway.
 - b. Chris Neaton Neaton Brothers Erosion Small Solar Energy System Mr. Neaton appeared before the board asking for a variance for a 50' by 150' solar

garden. There were no concerns from neighboring farm about the variance. Mark made motion to approve, seconded by Ron, MSC. (3-0-0)

- c. Building permits: Permits were reviewed for the following: United Farmers Cooperative, Chad Guetkow, Lois Wilmot, Timothy Kirkman, Northstar Properties.
- d. American Rescue Plan Clerk Henry-Neaton told the board about the program. This is a program that is the Federal Government's most recent response to the COVID 19 pandemic. The first step is to apply for the funds, townships have until December 2024 to aloocate the funding, and until December 2026 to complete projects. Bruce F. made motion to authorize the clerk to apply for funds, and Treasurer Filbrandt to be the contact person for the funds, seconded by Mark. MSC (3-0-0).
- e. Frontier permit for excavation Mark made motion to approve permit with the stipulation that any area excavated must be fixed to pre- excavation form, seconded by Ron, MSC (3-0-0).
- f. Meetings call ins Mark made motion to suspend meeting call ins until it is deemed necessary, seconded by Ron. MSC (3-0-0)
- 7) Old Business:
 - a. New Germany Solar Garden site update The company will be bringing in sheep to graze the property.
 - b. Luceline trail agreement with the DNR-Clerk Henry-Neaton is working with the DNR to get the agreement complete. Her representative has said that the agreement will be ready in the next few days and would like to have it signed and returned before June 30, 2021, Clerk Henry-Neaton would like the board to make a motion to approve the agreement that was discussed at the April and May meeting and authorize Chairman Filbrandt to sign it when it is received. Motion by Markto sign agreement, seconded by Bruce F., MSC (3-0-0)
 - c. Dust Control report dust control has been completed for the first round.
 - d. LRIP grant for 30th st. we did not receive the grant for the 30th st. project.
 - e. New Germany Fire contract update the \$10,000 added to this year total for the township will be ongoing each year. The board instructed Clerk Henry-Neaton to get a break down of the budget from the Fire Department where this is located.
- 8) Reports:
 - a. Mayer Fire Department Payment for township's part of the tanker is due. Will be paid next month.
 - b. Supervisor report Mark asked Bruce O. if he has been cutting hay. The hay policy was discussed and Bruce O. is trying to work around people making hay.
 Ron spoke about dust controlling the entire township. He asked about starting with a road to see how it would hold up It would cost \$4500 a semi load for dust coating 1 mile. Due to the large amount of money going out of the road and bridge fund this month due to the gravel, Mark made motion to re-evaluate at a later date, seconded by Bruce F. Ron opposed. MSC (2-1-0)

- c. Clerk's report Clerk Henry-Neaton informed the board that she has been contacted by the ATF regarding a permit request for selling guns in the township.
- d. Bruce O. report Bruce O shared the gravel has been down for the township as planned.

Carver County has contacted us regarding some questions about a culvert. There was discussion regarding 3 residents who have put in driveways, done something with the road ditch or culverts on their property. Clerk Henry-Neaton was instructed to send letters to the residents and ask them to attend the July monthly meeting of the township.

Bruce O. said he will be taking a vacation day here and there for the net month or so. Bruce O. would like to order 3 culverts needed for roads this year. Mark made motion for Bruce O to order culverts, seconded by Ron, MSC (3-0-0).

- 9) Additions: Bruce F. asked about the local organizations who have donated to the township in the past. Discussion was held about the Pull tabs policy.
