The township is looking at putting down dust coating to solidify the road. It was questioned if the gravel has enough binder in it to work. It is posted 5 ton but there have been vehicles beyond that weight on the road. The tile that was installed last year has helped. The resident will be back at the next meeting and will be on the agenda.

8) Old Business:

- a. Carver County Township Association Meeting Tuesday, July 26, 2022 7:00 PM Carver County Fairgrounds. Board needs to decide who will represent the board on County Township Association Board. Bruce F. made motion to appoint Mark to be on the Carver County Township Association board, seconded by Ron. MSC Mark abstained. (2-0-1) Ron will fill in if Mark can't attend.
- b. Contract for Sheriff services shared with City of Mayer. Mark and Pam attended a meeting with representatives from the City Of Mayer and the Carver County Sheriff's Department to discuss what could be done as far as sharing some services from the County Sheriff's Department. Hollywood township would buy 2 hours of service per month from the City of Mayer. Mark made motion to pursue an agreement/contract with Mayer, seconded by Bruce F. MSC (3-0-0).

Mark then made a motion that the cost (up to \$1500) for the services would be paid from fine receipts, this would go into the General fund and after the initial \$1500, the fine receipts would go into the Capital Equipment fund as they have been doing, seconded by Bruce F., MSC (3-0-0)

c. Election Update: Clerk Henry-Neaton reported that she has been very busy with election items. There are numerous trainings that she will be attending. The Primary is Tuesday, August 9, 2022. General election is Tuesday, November 8, 2022.

- a. Clerk's report An incident insurance report has been filed regarding the claim from January involving a resident's electrical wires. There was also some confusion from the last month's meeting with trees being cleaned up and the cost vs no cost. Discussion was held so it doesn't happen again.
- b. Supervisor's report

- c. Bruce O. report -
 - A light has been put on the building if the board feels it is good, he
 would like to put 3 more on the outside. This is a concern from
 the last election when we had a large amount of people and lights
 that were inadequate for safety.
 - He contacted Knife River about the gravel we have ordered for the summer. They are short on drivers and having difficulty getting deliveries done. He also contacted Meeker but at this time, they cannot help us out.
 - Road mowing is done.
 - He has been spraying weeds.
 - Roads on the east side have been groomed.
 - Two roads are set to be rip rapped.
 - He mentioned that there should be more insulation put in above the new doors. There is a dent in the tin at the bottom on right of doors.
- 10) Additions Bruce F asked what the township was going to follow up with on the concerns expressed by the resident at the beginning of the meeting. Ron and Bruce O. will talk to one of the people involved and Bruce F. will talk to another person.
