- Employee Handbook update Clerk Henry-Neaton updated the handbook, she added the Sick and Safe time policy and the increase in hourly wage. An update to the handbook will be done and brought back for a vote at the next month's meeting.
- c. New Germany Solar Garden Clerk Henry-Neaton contacted the county regarding the condition of the solar garden on Highway 7, they have been in contact with the new owners and are following up with the board and county's concerns.
- d. Right of Way Ordinance Carver County this was tabled until the next meeting, Mark will be checking with the county.
- 9) Reports:
 - a. Clerk's Clerk Henry-Neaton reported she was contacted from the county regarding the request for funds for ditch clean up, etc..., She said we will more than likely get some money but not the total amount we requested.

She also spoke about problems she is having with the township's computer. Mark made motion to use ARP funds (\$750) to purchase a new computer, it was suggested to increase that amount. Mark rescinded his motion and made a motion to allocate up to \$1000 for a new computer for the township clerk, seconded by Bruce F., MSC (2-0-0)

She informed the board that they county has been allocated money for the upcoming presidential election, the township will not receive a reimbursement check but it will be credited to our bills for supplies needed from the county. It's about \$60.00.

Discussion was held on election costs, at this time, there is no definite amount. She also told the board that she has been getting calls about the increase in the taxes from residents. Most are upset by it. She has explained it was voted on at the Annual Meeting in March.

- b. Supervisor reports:
 - i. Mark Mark spoke about the residence on Cty Rd 33. The county is talking to the resident to get it straightened out, (a curb cut was put in). The township received a check from Carver County who received the money from Jaguar in the amount of \$1000 for the installation of fiber optic in the township. The check was written from the Carver County Township Association. This money will most likely be used for any maintenance needed after the installation of the fiber optic. Jaguar gave the money to the county to be distributed as they seen fit. There was discussion again that the boxes have wires hanging out of them. Discussion was held on what account the money should be deposited in, Mark made motion to deposit it into the Road and Bridge fund because if there is any maintenance that would come from the Road and Bridge fund, seconded by Bruce F., MSC (2-0-0).
