- 8) Reports:
 - a. Clerk's Clerk Henry-Neaton reported that she has completed the Unemployment report and ARP report. She spoke of the damage at the tower site, delivering the Omni Ballot Machine, the report of tires dumped on Yancy Ave.. Also she said she is still working on getting the Certificate of Liability insurance from the company who mows the lawn.
 - b. Jeff -Jeff spoke about a ditch that there has been some concerns with. The county is willing to reshoot it and tying it into the GPS. Water is moving through the ditch, slope of the ditch will be checked by the county. Question was brought up could the amount of cattails affect the flow of water?
 - c. Bruce F. Bruce F asked about grading. He also asked about 30th St. There was discussion about how to handle the problems that continue on 30th st. Steve Burns will be at the road tour to discuss it with the board. Dust control is 12 feet wide, road is wider than that. Winsted township offers to it's residents they can pay the difference for the whole width of the road. Road was graveled in 2021.
 - d. Mark S Mark had nothing to report at this time.
 - e. Maintenance report Bruce O reported that Knife River will be coming on May 19th for about 3 days. Not sure when Reinart is coming but sometime after Memorial Day.
 - Roads are done on a 5 year rotation, should try for 4 year rotation. The Board talked about it and felt that dumping more gravel is not the answer.

Bruce said he had 40 tires to get rid of, he can bring them free of charge to the Mosquito Control. He also picked up a fridge.
