- i. Jeff asked clarification question regarding road and bridge. Mary clarified that it's what is in the account coming into the meeting.
 - ii. Jeff pointed out that the one sheet has the checks we are writing out today and should be a projection of what it will look like in the August meeting.

5.) Jeff discussion of Budget

- a. Asking Bruce O. about paying Reinhart. Bruce O. indicates this should be done tomorrow. Bruce O. will finish graveling 5 miles tomorrow and then 2 miles on the 30th project with Steve Burns. Everything that is down is paid for, which we have received 2 bills for.

- b. Bruce O. talking to Curt about the distance on the roads because some of the roads gained 150 ft (the bill is larger than it was last year).
- c. Jeff said we are not spending more on dust coating than what is allotted.
- d. Bruce still has 7 miles remaining to dust coat. Bruce F. asking why he isn't dust coating tomorrow. Bruce O. wants it to rain prior to oiling. Everything but 30th St. will be done on Thursday.
- e. Judy asked what they are doing on 30th.
 - i. Push back the middle of the road bring in crushed concrete and put that down and then put the gravel back on top. Once this is all done dust coating will go on. Steve Burns and Bruce O. are working on this project.

6.) Public Comment

- a. Mike Donahue
 - i. Drives the gravel roads quite a bit and thinks the roads are the best they have ever been. Thinks the roads are on the right track with the maintenance and the dust coating that has been taking place.
- b. Judy Waner
 - i. Has Bruce O. heard back regarding Tin Can Alley and the pitch of the culvert.
 - 1. Bruce O. has not heard back from Mike Warner. He invited him to the township meeting to talk to everyone. Bruce is going to try and contact him again. Bruce F. said he was going to drive by on Thursday and see if he can find him.
 - 2. Judy said that Jim Kieser said that as soon as they put the culvert in something was different. There had never been so much water before. Judy is thinking it might be the culvert under 33 that may be the problem.
 - 3. The township will fix, but we need someone to come along and say what the elevation is. If they don't have the elevation, we need someone from Soil and Water to give this number.

- a. Clerk's
 - i. Bruce O. will start 30th St. project in 2 – 3 weeks. Steve wants to go all the way down to the black top in Winstead and then down the middle area and then what can be done between Engelman's & Jopp's.
 - b. Jeff
 - i. Asking about spraying for thistles – Bruce O. normally gets out, but farmers aren't cutting their ditches. When Bruce gets done with the gravel and dust control he is going to go out and cut the ditches. Bruce did one pass on the 4th of July and is now going to do the second pass soon. Normally does spray for thistles, but they are blooming. He normally sprays for thistles about 3 weeks ago as they are getting tall enough to see them, but prior to them blooming. With all the rain, it is difficult to get out there because it all washes out. He will use some of the chemicals he purchased this year yet but will have some left over. He is unsure if the pump will work this year. County Road 21 is thistles 6ft wide, but the county and state are not doing anything. Watertown just bought a new sprayer (sprays about 3 ft longer than ours). Bruce has to actually get in the ditch to spray. Jeff mentioned looking to see if there were other options that would work. Bruce F. asked about the spray he bought this year, but Bruce O. said all he bought was a single gallon (this is expensive and explains the cost from last year).
 - c. Bruce F.
 - i. Bruce F. asked about 30th St. and dust coating the spots that aren't dust coated yet. Bruce O. said that at last meeting we said not to dust coat since there will be so many trucks on that road. Bruce F. said that there are a lot of people not getting dust control and they have paid taxes, and it is already July. Bruce O. said he should have received instructions awhile back to stockpile and then dust control. Bruce O. said he has texted and called Reinhart and haven't heard back. The supervisors discussed experience with Reinhart and to consider this experience next year. Jeff proposed to dust coat 30th St since Burns is 4 weeks out. Bruce O. said they will dust coast just past Jopp's Farm and then from Engle's to another two stretches. They will dust coast every section that will not be tore up.
 - ii. Mark expressed the work that Knife River has done has been great this year. Bruce O. said we could take the gravel and bring it to St. Cloud and

get it quality tested to use that as a reason to not move forward with them next year.

d. Mark S.

- i. Has someone who lives on 30th St. stopped and asked him when he was getting dust coating and expressed, he paid taxes for the dust coating.
- ii. Still perturbed about Zebra Ave.
- iii. Discussion about the work on county road 1. Thinking about putting up a sign that says “local traffic only” on 30th St. Bruce saw a couple of semis go by when he was out there. Bruce went to the City Engineer and got a number for the county engineer and told him that we have a problem with the detour traffic taking 30th. He asked why they are putting so much traffic on a road that can’t handle it. **Bruce O. asking them to come up with a solution and pay for dust coating. Jeff asking him to request a sign that says “local traffic only” or “no thru traffic”**
